Hence, you are requested to take necessary action as per rule.



With the objective to accept & adopt "The Scheme for Financial Assistance to Institutions Recognized as Adarsh Sanskrit Mahavidyalayas (ASM)/ Adarsh Sanskrit Shodh Sansthans (ASSS) - 2022" (hereinafter referred as Revised Adarsh Scheme-2022) and to measure the performance of the ASM/ ASSS on selected key parameters against the targets set to improve the performance on the critical parameters of the organisation.

This MoU has been structured into Six parts:

- Part 1: Acceptance and Adoption of the Guidelines of "The Scheme for Financial Assistance to Institutions Recognized as Adarsh Sanskrit Mahavidyalayas (ASM)/ Adarsh Sanskrit Shodh Sansthans (ASSS) - 2022".
- Part 2: Vision, Mission and Objectives
- Part 3: Exercise of Enhanced Recognition and Delegation of Powers
- Part 4: Performance Evaluation Parameters and Targets
- Part 5: Facilitation/ Assistance from the CSU
- Part 6: Action Plan for Implementation and Monitoring of the MoU



### PART-1. ACCEPTANCE AND ADOPTION OF THE GUIDELINES OF "THE SCHEME FOR FINANCIAL ASSISTANCE TO INSTITUTIONS RECOGNIZED AS ADARSH SANSKRIT MAHAVIDYALAYAS (ASM)/ ADARSH SANSKRIT SHODH SANSTHANS (ASSS) - 2022".

- 1.1. The Management Committee has read and understood "The scheme for Financial Assistance to Institutions Recognized as Adarsh Sanskrit Mahavidyalayas/Adarsh Sanskrit Shodh Sansthan-2022" and hereby undertake that, the Management Committee shall be liable to abide by all the terms and conditions of the Revised Adarsh Scheme-2022, notified by the Central Sanskrit University, Delhi vide Notification no. CSU/Ad/Revised Scheme/2023-24/444 dated 01.08.2023 and its amendments made from time to time. All the terms & conditions of the Revised Adarsh Scheme-2022 shall be binding upon the institution/Management Committee and the Management Committee shall not make any claim legally or otherwise, in case any action is taken by the CSU in accordance with the terms & conditions of Revised Adarsh Scheme-2022.

## PART-2 .VISION, MISSION AND OBJECTIVES :

### 2.1. Vision

To Develop ASM/ ASSS as a world class Institution with a view to establish the glory of Sanskrit learning and research at global context.

### 2.2. Mission

All round development of relevant branches of Sanskrit learning and availability of Sanskrit resources through modern systems.

Upliftment of linguistic diversity and cultural plurality while arranging for teaching and research in Sanskrit in the context of their mutual cultural inter-relationship.

Preservation and upliftment of the philosophical and scientific elements in the knowledge systems of Sanskrit & connected other languages and ensuring their availability through the equipment of information and communication technology while establishing the relationship of these knowledge systems with cultural legacy.

### 2.3. Objectives

The objectives of the ASM/ ASSS shall be to disseminate and advance knowledge by providing instructional, research and extension facilities to the promotion of Sanskrit

Language and such other branches of learning as it may deem fit; to make special provisions for integrated courses in humanities, social sciences and science in its educational programmes; to take appropriate measures for promoting innovations in teaching-learning process and inter-disciplinary studies and research; to educate and train manpower for the overall development, promotion, preservation and research in the field of Sanskrit, especially in Sanskrit traditional subjects. The objectives for which the ASM/ ASSS is established are to propagate, develop and encourage traditional Sanskrit learning, research and in pursuance thereof;

## PART-3. EXERCISE OF ENHANCED RECOGNITION AND DELEGATION OF POWERS

- 3.1. All such powers are available to the Management Committee of the ASM/ ASSS as are provided for by the Scheme for Financial Assistance to Institutions Recognized as Adarsh Sanskrit Mahavidyalayas (ASM)/ Adarsh Sanskrit Shodh Sansthan (ASSS) - 2022. The Management Committee shall not use its power to lay down any policy that has an overriding or overruling impact on Revised Adarsh Scheme-2022.
- 3.2. The ASM/ ASSS shall follow the General Financial Rules, 2017 and subsequent amendments issued from time to time by Department of Expenditure, Ministry of Finance, Government of India in all its financial transactions including procurement of goods and services.
- 3.3. The ASM/ ASSS shall adopt the Online digital systems like SAMARTH, Digital Attendance, PFMS etc. in the form directed by CSU, for receipt of all funds from CSU and make all payments through the DBT mode to the last mile as far as possible. The ASM/ ASSS shall instal/ establish CCTV, online video conferencing systems, e-office, creation of website with Suo-moto disclosures and any other digital initiatives as directed by the CSU for maintenance of transparency.

- 3.4. The ASM/ ASSS shall provide any of the information required by CSU, to satisfy any requirement related to Parliamentary Matter, RTI, Court Cases, Public Grievances, or inputs etc. to policy decision to be taken by the CSU/UGC/MoE within the time specified by the CSU/UGC/MoE.
- 3.5. As per policy matters mentioned in Scheme i.e. Centralised Recruitment, adoption of transfer and any other delegation of power needed will be taken up separately by the ASM/ ASSS with CSU.
- 3.6. ASM/ ASSS shall manage its financial affairs through one unified account maintained in the name of ASM/ ASSS and accordingly, the ASM/ ASSS shall have separate PAN/TAN in the name of the institution. The account(s) shall be operated jointly by the Principal/Director and two senior faculties of ASM/ ASSS, nominated by the Management Committee.

#### PART-4. PERFORMANCE EVALUATION PARAMETERS AND TARGETS

- 4.1 In fulfilment of its obligations under the MoU, ASM/ ASSS shall undertake to achieve certain level of performance in each year. The performance of ASM/ ASSS will be evaluated using the criteria fixed by the CSU.

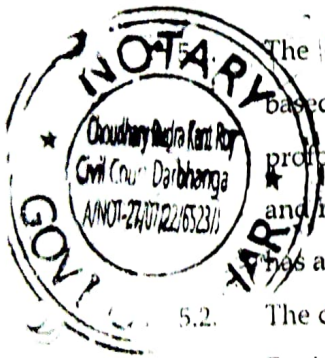
#### PART-5. FACILITATION/ASSISTANCE FROM THE CSU

- The Institution shall make the commitment of Performance Evaluation Targets, based on certain assumptions, as indicated in the Performance Evaluation Target proforma, provided by the CSU every year, in respect of release of grants from CSU and raising of other resources, including expansion of infrastructural facilities, which has a direct bearing on the performance of the Institution committed in this MoU.
- 5.2. The commitment of CSU and other possible sources of revenue generation are as per Revised Adarsh Scheme-2022.
- 5.3. CSU will extend any other Facilitation/ Assistance like taking up the matters with the Government concerned or any Ministry of the Union Government, as and when required.

#### PART-6. ACTION PLAN FOR IMPLEMENTATION AND MONITORING OF THE MoU

- 6.1. Performance evaluation against these MoU parameters shall be carried out every quarter and monitored by the ASM/ ASSS.

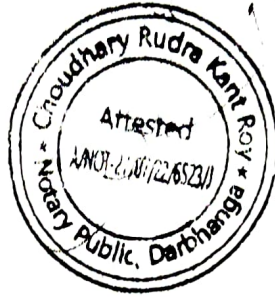

- 6.2. The performance evaluation shall be submitted to the Management Committee of concerned ASM/ASSS during the Management Committee meetings for information. After the Management Committee meeting, the same shall be sent to CSU along with its recommendations.
- 6.3. A joint review by the ASM/ASSS and CSU shall be carried out within 90 days of completion of the every financial year. The result of the joint review shall be placed before the Management Committee and hosted prominently on the website of the concerned ASM/ASSS.
